

The proposal

Leeds City Council in partnership with the Leeds North West Education Partnership Foundation, is prospering to establish an 12 (increasing to 16) place resource provision at Cookridge Primary School for children with speech, language and communication needs.

Cookridge Primary School, is rated 'Good' by Ofsted and has experience supporting children with special educational needs, and will use this provision to enhance the education of current pupils and extend support to children from the wider Leeds area.

The proposed opening date is September 2026.

Need for additional resource provision places in Leeds

The number of children and young people living in Leeds with an Education, Health and Care Plan (EHCP) continues to increase each year, resulting in rising demand for specialist provision places.

A resource provision caters for children with an EHCP who require a specialist environment within a mainstream school to support their needs. A need for this type of provision has been identified in this area of Leeds.
