All Leeds maintained schools have a similar approach to meeting the needs of pupils with Special Educational Needs and are supported by the Local Authority to ensure that all pupils, regardless of their specific needs, make the best possible progress in school. All schools are supported to be as inclusive as possible, with the needs of pupils with a Special Educational Needs and or Disability being met in a mainstream setting wherever possible, where families want this to happen.

### Admissions

Students with SEND are allocated places in the following way:

- Those pupils who have SEND but do not have an Education, Health and Care Plan (EHCP) are admitted via the normal school admissions criteria.
- Those pupils with EHCPs, must request for Cookridge Primary School to be named on their EHCP and this must then be sent to your child's case work officer, who will then inform the school of your choice. The named school will then be sent your child's EHCP and consider if the placement will be able to meet the needs of your child as described in the EHCP. You will be then advised by your case work officer if the school is able to meet their needs or not.

### HOW COULD MY CHILD GET HELP IN SCHOOL?

Pupils will be offered additional SEN support when it is clear that their needs require intervention which is “additional to” or “different from” the well-differentiated curriculum offer for all pupils in the school i.e. they have a special educational need as defined by the SEN Code of Practice 2015. We identify this need by following the graduated approach (assess, plan, do, review).

This SEN support may be provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the Sensory Service (for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language therapy (SALT) Service and Educational Psychology Service

<b>What are the different types of support available for children with SEND in this school?</b>	<ul style="list-style-type: none"><li>• Our school's provision map shows the range of interventions in place in our school which may be used when we identify a need for additional support.</li><li>• When the school identifies the need for additional intervention to enable a pupil to make expected progress, the parents/carers will be informed of the planned support and may be invited to a meeting at the school / be contacted by telephone to discuss this further or a letter sent home outlining the intervention. If the pupil meets a criteria for special educational needs or disabilities (SEND), a pupil passport will detail the exact support the pupil will receive at Wave 1, Wave 2 and Wave 3.</li></ul>

	<ul style="list-style-type: none"><li>Within 6 weeks after the school (or parent) have sent the request to the Local Authority (with collective information about your child) a Local Authority Panel (with multi agency personnel) is held to discuss the request and decide whether or not to proceed with the EHC Needs Assessment. This decision is made by the Local Authority. If it is decided not to proceed with the EHC Needs Assessment, the family are signposted to alternative sources of support with the Local Offer.</li><li>If it has been agreed that an EHC Needs Assessment is appropriate, the council will gather any further evidence and advice required from people who are involved with the child/young person and family. Professionals contacted for information about an Education, Health and Care (EHC) needs assessment have six weeks to respond. This is a legal requirement, regardless of how many people are involved or how long the wait is. In some cases, the council may decide that the support required for the child or young person is available through a supportive action plan and would not need EHC plan.</li><li>Once a draft plan is written the local authority must send the draft EHC plan (including the appendices containing the advice and information gathered during the EHC needs assessment) to the child's parent or to the young person and give them at least 15 days to give views and make representations on the content. During this period, the local authority must make its officers available for a meeting with the child's parent or the young person on request if they wish to discuss the content of the draft EHC plan. A next steps meeting will be held, and everyone who has contributed to the plan, including parents/carers are invited.</li><li>The Education, Health and Care Plan will outline the support your child will receive from the LA and how the support should be used and what strategies must be put in place. <b>How will both you and I know how my child/young person is doing and how will you help me to support my child's/young person's learning?</b>	<ul style="list-style-type: none"><li>• Annual school reports and Parents' consultations give all parents and carers regular feedback on their child's up to date academic levels, individual targets and any behavioural, emotional or social difficulties.</li><li>• When appropriate, parents/carers may be contacted mid-term to discuss the support that the school are providing and how they can help their child at home: this may be a phone call or an online meeting. Pupils' views will be obtained and when appropriate, they may attend all or part of any meeting.</li><li>• Pupil passports are shared and discussed with parents. Parents/ carers and pupils are involved in developing their targets and the progress they make towards achieving them.</li><li>• Pupils with a pupil passports will be able to add information, comments and work to highlight progress.</li></ul>
<b>How can I let the school know I am concerned about my child's progress in school?</b>	<ul style="list-style-type: none"><li>• If you have concerns about your child's progress you should speak to your child's teacher initially, by booking an appointment.</li></ul> <p>The concerns may need referring if your child is still not making progress, to the SENDCo Mrs C Kerr, a member of the SEND Team and Leaders of Learning: Mr N Kershaw – Upper Key Stage 2, Mr S Gamble – Lower Key Stage 2, Mrs H Koopman – Key Stage 1, Mr B Kerr – Foundation Unit</p> <ul style="list-style-type: none"><li>• If you continue to feel that your child is still not making progress you should speak to the Headteacher or the school SEND Governor.</li></ul>
<b>How will the school let me know if they have any concerns about my child's learning in school?</b>	<ul style="list-style-type: none"><li>• When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher must raise this with the SENDCo.</li><li>• At Cookridge Primary School we hold termly pupil progress staff meetings at which children who give concern are discussed and appropriate actions agreed and reviewed. Teachers are able to raise any concerns and seek advice from the SENDCo whenever there is a need.</li><li>• At Cookridge Primary School, there are regular meetings within the Key Stage teams to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as they could be.</li><li>• If your child is then identified as not making progress the school will set up a meeting to discuss this with you in more detail.</li></ul>

<b>How is extra support allocated to children and how do they move between the different levels?</b>	<ul style="list-style-type: none"><li>● Quality First Inclusive Practice (Wave 1) is clearly defined in our setting and we expect all staff to deliver this.</li><li>● Should additional (Wave 2 or 3) support be required, this is undertaken after consultation with the relevant staff, the learner and their families as necessary. All interventions are monitored for impact and outcomes are defined at the start of any intervention. The SENDCo team oversees all additional support and regularly shares updates with the SEND Governor.</li><li>● The school budget, received from Leeds City Council, includes money for supporting children with SEND.</li><li>● The Head Teacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of needs in the school.</li><li>● The Head Teacher and the SENDCO team discuss all the information they have about SEND in the school, including<ul style="list-style-type: none"><li>○ the children getting extra support already</li><li>○ the children needing extra support</li><li>○ the children who have been identified as not making as much progress as would be expected.</li></ul></li><li>● Decisions are then made in regard to what resources/training and support is needed.</li><li>● All resources/training and support are reviewed regularly and changes made as needed.</li></ul>

<b>How are the teachers in school supported to work with children with an SEN and what training do they have?</b>	<p>The job of the SEND team is to support the teachers in planning for children with SEND.</p> <ul style="list-style-type: none"><li>• The school supports continuous professional development as a priority to enable staff to improve the teaching and learning of children including those with SEND. The SENDCo has completed the National College Award for SENDCo's (NASENCO). This includes whole school information &amp; training on SEND issues such as Autism, dyslexia, attachment etc.</li><li>• Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g., from the Speech and Language Therapist, STARS</li></ul>	
<b>How will the teaching be adapted for my child with learning needs (SEND)?</b>	<ul style="list-style-type: none"><li>• Teachers plan lessons according to the specific needs of all groups of children in their class.</li><li>• Support staff will support with your child's learning in the classroom.</li><li>• Specific resources and strategies will be used to support your child individually and/or in groups.</li><li>• Planning and teaching will be adapted on a daily basis if needed to try to meet your child's learning needs.</li><li>• Quality First Inclusive Practice (Wave 1) is clearly defined in our setting and we expect all staff to deliver this.</li><li>• Should additional (Wave 2 or 3) support be required, this is undertaken after consultation with the relevant staff and the learner as necessary. All interventions are monitored for impact and outcomes are defined at the start of any intervention. The SENDCo oversees all additional support and regularly shares updates with the SEND Governor.</li></ul>	
<b>How will we measure the progress of your child in school?</b>	<ul style="list-style-type: none"><li>• Your child's progress is continually monitored by their teachers and Key Stage leaders.</li><li>• Their progress is reviewed formally every term and an assessment is given.</li><li>• If your child is not accessing the area of curriculum linked to their year group, your child will be assessed using another scale of levels that assess attainment. The levels are called 'B squared'.</li><li>• At the end of Key Stage 2 the school is required to report English, Maths and Science National Curriculum levels for your child. This is something the government requires all schools to do and the results are published nationally.</li><li>• The progress of children with an EHC Plan is formally reviewed at an Annual Review with all adults involved with the child's education and the child themselves if appropriate. Review meetings can be held more regularly if there is an identified need.</li><li>• The SENDCo team will also check that your child is making good progress within any individual work and in any group that</li></ul>

<b>What support do we have for you as a parent of child with SEND?</b>	<ul style="list-style-type: none"><li>• We work in partnership with parents to support each child/young person's well-being, learning needs, progress and aspirations.</li><li>• If you have any concerns regarding your child, please book a meeting with your child's class teacher or e-mail the school office. All of this information is passed onto Mrs Kerr, the SENDCo in school.</li><li>• We would like you to talk to your child's teachers, Key stage leader, by pre booking meetings so we know what they are doing at home and we can tell you about what we are doing in school. We hope this will make sure that we are doing similar things to support your child both at home and school and can share what is working in both places.</li><li>• The SENDCo is available to meet with you to discuss your child's progress or any concerns/worries you may have and will also hold pupil progress meetings for those children identified as needing SEN Support or for those who have an EHC Plan.</li><li>• All information from outside professionals will be discussed with you directly, or where this is not possible, in a report. The SENDCo team will also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.</li><li>• Homework will be adjusted as needed to your child's individual needs.</li></ul>
<b>What support will there be for my child's/young person's overall well-being?</b>	<ul style="list-style-type: none"><li>• The well-being of all of our pupils is our primary concern at Cookridge Primary School. They are supported with their social and emotional development throughout the school day, through the curriculum and extra-curricular activities. Personal, Social and Health Education (PSHE) and Social and Emotional Aspects of Learning and Restorative Practice are integral to our curriculum.</li><li>• Additional support from specialist staff is arranged as needed for individual pupils, both in and out of the classroom; a tailored personal plan may be put in place for pupils with the highest need.</li><li>• Our Behaviour Policy; which includes guidance on expectations, rewards and reflection time is fully understood and in place by all staff.</li><li>• We regularly monitor attendance, support pupils returning to school after absence and take the necessary actions to prevent prolonged unauthorised absence.</li><li>• Relevant staff are trained to support medical needs and in some cases all staff receive training. We have a medical policy in place.</li><li>• SEND pupils' views are sought through pupil voice and regular check ins.</li></ul>

<b>How have we made Cookridge Primary School accessible to children with SEN? (Including after school clubs etc.)</b>	<ul style="list-style-type: none"><li>• Cookridge Primary School is an inclusive setting that welcomes all children regardless of their abilities.</li><li>• The school is accessible to children and adults, with disabled access and toilet facilities.</li><li>• We ensure that equipment used is accessible to all children regardless of their needs.</li><li>• Key words and literacy resources are used across the school to support learning.</li></ul>
<b>How will we support your child when they are leaving this school? OR moving to another Year?</b>	<ul style="list-style-type: none"><li>• We have an Induction process in place for welcoming all new learners to our setting including home visits wherever possible.</li><li>• We have very good relationships with our feeder settings and the settings that most of our pupils move onto; we share information to support pupils' learning and well-being at transition.</li><li>• Further support is provided as necessary for those with SEND including additional visits to the new setting, both individually and as part of an enhanced transition programme for identified pupils.</li><li>• Information is regularly shared between key stage teams so that children's progress is consistently monitored and evaluated.</li><li>• Pupils are provided with key information (where possible), such as pictures of staff, to support them with transitional periods.</li></ul>
<b>What training have the staff supporting children and young people with SEND had or are having?</b>	<ul style="list-style-type: none"><li>• We regularly invest time and money in training our staff to improve Wave 1 provision for all students, to develop enhanced skills and knowledge to deliver Wave 2 (short term support interventions) and Wave 3 (individualised support and interventions).</li><li>• Our Special Educational Needs Co-ordinator (SENDCo) is a qualified, experienced teacher and holds the National Qualification in Special Educational Needs, as well as receiving ongoing SEN training in specific areas.</li><li>• All our teachers hold qualified teacher status and all staff members, including TAs and HLTAAs, receive regular training to best support our pupils with SEND.</li></ul>
